I am pleased to present the program for the **Thirty-second Annual Conference** of the Association for Jewish Studies. The program reflects a great deal of hard work on the part of many people, and I want to thank all participants for what promises to be a series of rich and rewarding sessions.

#### Hotel

This year, AJS returns to Boston where we'll be meeting for the first time at the newly renovated Sheraton Boston Hotel; the hotel offers extensive facilities, and has direct entrance into The Shops at the Prudential and the Copley Place Mall. All sessions will be held in the Sheraton's meeting rooms. Floor plans at the end of this Program Book show their location and arrangement. Session numbers are keyed to both meeting times and rooms, to enable you to arrive at the correct hour and to identify the meeting room more easily.

#### FOURTH ANNUAL AJS DISTINGUISHED LECTURE

Each year AJS recognizes the important contributions of a senior scholar with the Distinguished Scholar Lecture, held following the Banquet. This lectureship honors individuals whose contributions to learning, while often located outside the realms of Judaic Studies as such, have nevertheless had a significant impact on the scholarly lives of many of our members.

This year's lecture will be delivered by Professor Fritz Stern, University Professor Emeritus at Columbia University, who will speak on "Albert Einstein and the German Question." In 1999, Prof. Stern received the prestigious Friedenspreis des Deutschen Buchhandels. His latest books are *Einstein's German World* (1999) and *Das Feine Schweigen* (1999). Other published works include *The Varieties of History*, ed. (1956), *The Politics of Cultural Despair* (1965), *The Failure of Illiberalism: Essays on the Political Culture of Modern Germany* (1972), *Gold and Iron: Bismarck, Bleichroder and the Building of the German Empire* (1977), and *Dreams and Delusions: the Drama of German History* (1987).

We hope you will join us for the Banquet in Constitution Ballroom A prior to Professor Stern's lecture. There will be plenty of seating for those who prefer to join us after dinner.

#### FILM AND SPECIAL PROGRAMS

After the lecture on Sunday evening, we will show a newly restored print of the classic Yiddish film *The Wandering Jew* (1933) in Independence Ballroom. We thank Sharon Pucker Rivo and the National Center for Jewish Film at Brandeis University for making this film available.

The American Academy for Jewish Research will again be holding sessions in conjunction with AJS. These programs, which will be held Monday during Sessions 4 and 5 in Republic Ballroom B, are open to all AJS attendees. The AAJR has a long and distinguished history, and it is once again an honor to welcome the Fellows of the Academy to our meeting.

Monday evening will feature excerpts from the musical theater production, *The Memoirs of Glückel of Hameln*, created and performed by members of the Great Small Works theater company. Their complete version of *The Memoirs* premiered to great acclaim in New York City in January 2000. We thank Jenny Romaine and the other members of Great Small Works for making this production available to us, and we are indebted to the Lucius Littauer Foundation, the AJS Women's Caucus, and the Jewish Women's Archive, and NFJC for their sponsorship. A short panel discussion with members of the Great Small Works company will follow the performance.
